Informative(s):

1 The site is a grade-II*-listed modernist university by Lasdun.

The applicant wishes to remove 13 internal partitions to create larger rooms, to install one new partition, to install 11 new doorways and to widen two doorways.

The partitions are plain some are not original. Consequently, the removal of a small number of them will not harm the special interest of the listed building, especially when weighed against the benefits to the institution. The new doors will match the existing.

The application has been advertised in the press and by means of a site notice, whereby there were no consultation responses. Historic England has issued a letter of flexible authorisation which has been ratified by the NPCU. The site's planning history has been taken into account in making this decision.

Special attention has been paid to the desirability of preserving the special interest of the listed building, under s.16 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013

As such, the proposal is in general accordance with policy D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the NPPF.
