Rear Garden:

T1: Cotoneaster: Approximately 5.00m. Reduce back to clear building by approximately 2.00m. Remove dead wood throughout. Reduce crown height by 15-20%. Reduce lateral and sub-lateral growth by up to 20% to form a balanced crown shape. Thin crown density by 20%.

T2: Prunus: Approximately 6.00m. Growing adjacent to the Cotoneaster. Holding a significant amount of dead wood. The tree does serve to form part of a joined crown area with the Cotoneaster. Fell to ground level and treat with systemic herbicide. Reason: weak specimen and is growing within the canopy of the Cotoneaster.

G1: Group of Viburnum & Small Cherry: Approximately 6.00m. Fell and remove root balls. Reason: The trees are very close to a retaining wall and the cherry is a poor/weak specimen.

Reason: General maintenance unless otherwise specified.
