15 – 17 TAVISTOCK PLACE, CAMDEN, WC1H 9SH APPLICATION FOR NON MATERIAL AMENDMENT TO PLANNING PERMISSION REF. 2015/3406/P (SUBSEQUENTLY AMENDED BY S73 APPLICATION REF. 2017/5914/P) SUBMITTED VIA THE PLANNING PORTAL. REF. PP- 07487834

On behalf of our client, The London School of Hygiene and Tropical Medicine (the School), please find enclosed an application for a non-material amendment under Section 96A (S96A) of the Town and Country Planning Act ("The Act") to amend the permitted scheme comprising works permitted by Planning Permission 2015/3406/P as subsequently amended by Section 73 Application Ref. 2017/5914/P.

Section 96A provides an appropriate mechanism for a local planning authority to make a change to any planning permission relating to land in their area if they are satisfied that the change is not material. In deciding whether a change is material, a local planning authority must have regard to the effect of the change on the permitted scheme.

This application seeks non-material amendments to the external appearance and internal layout of the existing and proposed buildings, in summary:

- The retention of the existing gable wall;
- Omission of proposed Stair Case 2;
- Relocation of the TP 1 reception;
- Revised proposal for bike storage replacing existing bike racks in the Dairy Shed; and
- Revision of door locations.

Background

The London School of Hygiene and tropical Medicine received Planning Permission in January 2017 for:

"Demolition of existing shed buildings (Class D1) and erection of a part single, part two-storey, part three-storey medical research laboratory and higher education facility (Class D1) with basement accommodation (2 floors) and associated plant on roof."

Following further design work and University College London's withdrawal from the scheme, the School secured minor-material amendments to the permitted scheme in June 2018, including:

- Basement size reduction;
- Removal of flue stacks (associated with removal of 'wet laboratory' facilities;
- Insertion of windows; and,
- · Addition of smoke reservoir.



Since that time, further surveys and design work has been undertaken and it has become necessary to make a series of very minor changes to the permitted scheme. These are of a scale, both individually and combined, which are considered not to materially affect the overall scheme, and as such can be appropriately dealt with via the submission of an application under Section 96a of the Act.

Please refer to the submitted plans in which the changes are itemised and bubbled in red in order that they can clearly be assessed against the approved scheme.
