(TPO REF. C1194 2018) FRONT GARDEN: 1 x Sycamore (T1) - Fell to ground level and treat stump.

The Council has considered your application dated 13 December 2018 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

1 This decision is valid for 2 years from the date of this decision or until the work is completed, which ever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)



Reason: To ensure the preservation of the amenity value and health of the tree(s).

3 Prior to the end of the March 2019, a Crataegus monogyna (hawthorn) tree shall be planted as a heavy standard with a girth size of 12-14cms. The tree should be planted and maintained to the standards set out in BS8545:2014. The tree shall be planted within the front garden at least 1m from any structure. The tree should be suitably staked and tied.

Reason: In order to comply with the provisions of Section 206 of the Town and Country Planning Act 1990 (as amended).
