Proposal:

(TPO REF. C49-T3) FRONT GARDEN: 1 x Ash (T1) - Reduce crown by approximately 20-25% to previous reduction points.

(TPO REF. C49-T2) REAR GARDEN: 1 x Lime (T3) - Reduce crown back to previous reduction points, reduce crown density by 20% and raise crown over pavement by 1m.

(TPO REF. C49-T1) 1 x Lime (T4) - Reduce back to previous reduction points, remove epicormic growth from the fence and raise crown by 1m.

(TPO REF. C49-T54) 1 x Beech (T5) - Thin crown density by 20% and reduce extraneous branches back into main crown structure (not more than 15-20%) in order to maintain the tree at reasonable dimensions for its location.
