Ash tree: the tree has been previously reduced. There is a large scar on the base of the tree as well as several pockets of rot in the base at ground level. To take some of the weight and area open to movement in the crown due to the wind we are suggesting the reduction of the crown to the previous points, approximately 3 metres of regrowth
