T2 Lime x 1 (Tilia spp) Previously reduced Lime tree in the front garden of No.31 Bartholomew Road that has become overgrown and prevents light from reaching the property. Suggested works: Re-reduce all aspects of the crown back to previous pruning points. (2-2.5 meters re-growth)  
Rear garden  
T3 Rowan/Mountain (Sorbus aucuparia) Medium sized, mature Rowan in the rear Ash x 1 garden that has died very recently due to the presence of honey fungus within the gardens. Suggested works: Fell to ground level and remove all timber and waste from site. Cut stump as level as possible so the residents can place pots on it.  
Rear garden  
T4 Lime x 1 (Tilia spp) Large, mature, heavily reduced Lime tree in the rear garden. This tree seems to have been reduced 6 years ago as the re-growth is approx. 3-3.5 meters in length. Due to its location with a crown that spreads over several gardens, pruning is now required. Suggested works: Re-reduce all aspects of the crown back to previous pruning points. Reduce the limb that extends out towards the rear neighbouring property by 1.5 meters past the previous point to minimise the overhang.
