CONDITIONS OF CONSENT

- 1. Except with the previous written consent of the Council, only the amenities detailed on the consent are to be placed on the public highway, and the amenities detailed are only to be placed on the public highway between the times detailed on the consent.
- 2. It is intended that the Council will mark a defined area on the public highway. When these markings are provided the amenities must be sited within them but, in any event, a minimum clear footway width of 1.8 metres is to be provided at all times for through pedestrian movement.
- 3. The applicant shall indemnify the Council from and against any claim in respect of any injury damage or loss arising directly or indirectly out of the grant of this consent and the use by the public of the amenities.
- 4. The applicant shall be responsible for cleaning the public highway used under consent at the end of each day and, if requested to do so by the Council, provide mobile litter bins on the public highway, in such positions and for such time periods as the Council may specify.
- 5. The applicant shall remove the amenities from the public highway immediately if requested to do so by the Council, its agents or contractors or licensees or by a statutory undertaker, its agents or contractor, or by a Police officer. If unimpeded access to the surface of the public highway is required to enable the Council, the Statutory Undertaker or the Police to carry out any of their statutory duties or to enable a licensee of the Council to put into effect the terms of the license. - 6. The Covent Garden Community Association (CGCA) OBJECTS to the renewal of permission for tables & chairs outside Rossopomodoro restaurant on Monmouth Street.

These premises have been the subject of complaints in the past, but local residents tell us that they have given up trying to complain because there is no way they can find on the Camden website to report breaches of this nature.

CGCA made a formal complaint to you by email in May this year, however. On 25/05/18 this was sent to Afshar Ahmed, copied to Vicky Wallas and Julia Peterson.

The background to the situation includes the fact that in 2009 the restaurant applied for additional hours for its tables & chairs. There had already been many complaints because of their abuse of the permission. Abuse included the sort of obstruction shown in the photograph below, with far too little clear footway left for pedestrians. Yet, despite this, you granted hours in excess of those stated as the maximum that you will consider in your guidance, being 9pm. You granted a terminal hour of 11pm Monday-Thursday, which was way in excess of anything else in the area.




There have been problems ever since.

Due to obstruction, and many more complaints, the number of permitted tables & chairs was in 2010 reduced so that 1.8m clear footway could be maintained. However, two problems continue:

- 1. Disturbance continues too late for residents.
- 2. The restaurant allows its tables and chairs to be used beyond even the 11pm deadline.
- 3. The restaurant allows chairs to be moved away from the permitted layout and in a way that obstructs the footway again.

Below we show a photograph taken in May 2018 at 11.10pm and showing a third chair that is not in the permitted plan.

Do these customers look like they are going to finish using the furniture anytime soon? Their wine glasses are still full. No, groups like this continue to make a noise well after 11pm and the furniture is taken in well after 11pm, too. With metal-framed furniture this is doubly noisy.



You are aware of the 'noise canyon' effect in the densely residential Seven Dials area, where sound echoes in the narrow streets. Noise peaks are created even from quite moderate sounds after the area falls very quiet, usually around 10pm.

Yet you allow premises like this to carry on behaving in ways that show no respect for your rules nor for their neighbours. And you have continued to allow them exceptionally generous terms beyond your guidance, leading to people being disturbed after 10pm.

We should also report that the restaurant puts other things out on the footway which cause obstruction. Below is an example of a tree in a large plant pot, leaving about 1 metre width of usable pavement. The photo was taken at night, but during the day the pavements in this area can be very crowded indeed and it is dangerous.




Please refuse this application and ask the restaurant to mend its ways.

You may feel it reasonable to grant permission for 5 tables & 10 chairs to be kept strictly in line as shown on the plans until the usual hour of 6pm stated in your guidance. If the restaurant is then able to manage things in the way that you have granted for, say, 6 months, then a later hour could again be considered.

We have to say, however, that after so many years of difficulties we believe that a clearer message would be sent if you were to refuse permission altogether and allow the restaurant to reapply in 12 months' time.
