T1 Sycamore x 1 (Acer pseudoplatanus) Large mature Sycamore tree in the front garden at number 40. This tree has been previously reduced approx. 5 or 5 years ago. The re-growth is 5-6 meters long and when in leaf, blocks any light from reaching the ground floor flats. Suggested works: Re-reduce all aspects of the crown back to previous pruning points. (4-5 meters) Remove all deadwood. Retain some furnishing growth in order to facilitate a healthy recovery.
