Thank you for contacting us on 20 November 2018 seeking our advice on proposals for the above site.

Advice

Historic England welcomes the submission of this Heritage Agreement Method Statement, which provides details of the dismantling, protection, transportation and storage of the Grade II listed Christie Memorial as part of the implementation of the HS2 development. The details provided in the method statement are as discussed with Historic England staff, and we support the approach taken to protect this monument during work on the railway. We recommend that HS2 put in place clear agreements with Christie Global and the London Borough of Camden (para 1.4.3) to ensure that the monument is re-assembled in an appropriate place, once this has been selected. Accordingly we look forward to receiving the outstanding details covering Schedule 1A, Part 2 (c) and (d) of the Heritage Agreement in due course, namely:

c) the process for the identification of an appropriate site for re-erection; and

d) the process for re-assembly of the component parts during re-erection of the Monument.

You do not need to consult us again on these plans at pre-application stage unless, as the scheme develops, there are changes to the proposals which would affect the historic environment.

It may be appropriate to seek the advice of relevant amenity societies on your proposals.
