Remove epicormic growth, cut back crown to points of previous reduction to leave a bare framework.

T3 = XLarge ASH - Thin crown by 20% removing deadwood.

T4 = XLarge SYCAMORE -Remove deadwood and broken branches ONLY.

T5 = Medium PEAR - Thin crown by 20%, lightly reduce upper regrowths.
