

**IMPORTANT – THIS COMMUNICATION AFFECTS YOUR PROPERTY****TOWN AND COUNTRY PLANNING ACT 1990 (AS AMENDED BY THE  
PLANNING AND COMPENSATION ACT 1991)****ENFORCEMENT NOTICE****ISSUED BY: THE LONDON BOROUGH OF CAMDEN**

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.
  
2. **THE LAND TO WHICH THE NOTICE RELATES**  
  
**Land at: : 25 - 26 Red Lion Street, London, WC1R 4PS** as shown outlined in black on the attached plan (“the Property”).
  
3. **THE BREACH OF PLANNING CONTROL ALLEGED**  
  
**Without planning permission:** the installation of louvre panel to front elevation at ground floor level with associated extraction system serving the dining room.
  
4. **REASONS FOR ISSUING THIS NOTICE:**
  - a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
  
  - b) The louvre panel, by reason of its design, siting, material and colour, is considered to be harmful to the character and appearance of the host building and the character and appearance of this part of the Bloomsbury Conservation Area, contrary to policies D1 (Design) and D2 (Heritage) of the London Borough of Camden Local Plan 2017.

- c) The extraction system, by reason of noise disturbance and lack of supporting details to address and mitigate noise impacts, causes unacceptable harm to the amenity of surrounding residential occupiers, contrary to policies A1 (Managing the impact of development), A4 (Noise and vibration), and TC4 (Town centre uses) of the London Borough of Camden Local Plan 2017.
- d) The extraction system, by reason of odour disturbance and lack of supporting details to address and mitigate odour impacts, causes unacceptable harm to the amenity of surrounding residential occupiers, contrary to policies A1 (Managing the impact of development), A4 (Noise and vibration), and TC4 (Town centre uses) of the London Borough of Camden Local Plan 2017.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

## 5. **WHAT YOU ARE REQUIRED TO DO**


Within a period of **One month** of the Notice taking effect:

- 1) Totally remove the louvre panel and reinstate a fixed window panel to match the existing adjacent windows on the shopfront with regard to the material, colour, texture and profile; and
- 2) Cease use of the extraction system serving the internal dining room.

## 6. **WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **Friday 8th March 2019** unless an appeal is made against it beforehand.

**Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002**
