T1 Cherry x 1 (Prunus spp) Large mature previously reduced Cherry tree in the front garden of the property. Suggested works: Reduce the crown height by 1/3rd. (5-6meters) Reduce the crown sides to match. The idea is to retard the root growth, water uptake and overall size of the tree. Once pruning work has taken place and we've seen how the tree has responded we will then decide how to further manage this tree.
