• Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.
• Thin crown to remove approximately 20% of live branches to improve light and air penetration through crown.
Most thinning cuts will be between 1 and 3 centimetres in diameter.
• Reduce crown spread by approximately 1-1.5 metres to enhance natural form.
