I just tried to call you to talk about this, but without success.

We have had a look at the revised plan for the Camden Lock Hotel. On the face of it our concerns with the original proposals for the roof extension have not been addressed. The absence of the corner chamfer and the dark grey metal cladding have not been amended, other than the sharp corner now being slightly rounded off. So unless we are missing something we still think the roof extension obtrusive. In other respects the proposed changes do at least serve to tidy up the building.
