1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

3 The development hereby permitted shall be carried out in accordance with the following approved plans:

101; 102; 103; 104; 110; 301; 302.

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission:

The proposed door opening is considered appropriate in its scale and height along the elevation as it matches the scale of the other doors along the same elevation of the site. The proposed door would be constructed of a power coated metal frame with glass panels. The proposed design of the door would match the existing metal and glass exterior of the building. Therefore, it is considered the proposed door would not detract from the character and appearance of the building or the surrounding street scene.

Due to the minimal scale of the works, the proposal would not impact upon the amenity of adjoining residential occupiers.

No objections were received prior to making this decision. The application site's planning history and relevant appeal decisions were taken into account when coming to this decision.

Therefore, the proposed development is in general accordance with policies A1 and D1 of the London Borough of Camden Local Plan 2017. The development also accord with the London Plan 2016 and the National Planning Policy Framework.
