Proposal:

Erection of single storey rear extension at lower ground floor level and two storey side extension at lower ground and ground floor level to facilitate amalgamation of two residential units (1 x 2 bed at first, second and third floor and 1 x 1 bed at lower ground floor level) to 1 x 3 bed maisonette with associated private rear garden.

Condition(s) and Reason(s):

- 1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

- 2 The development hereby permitted shall be carried out in accordance with the following approved plans: Site location plan, A000, A001, A002, A010, A011, A012, A013, A014, A020, A021, A022, A030, A031, A032, A100, A101, A102, A118, A200, A201, A202, A300, A301, A302, Tree Report, Planning Design and Heritage Statement, Arboricultural Assessment - Addendum Report (Rec'd 04/02/19).

Reason:

For the avoidance of doubt and in the interest of proper planning.

- 3 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 if in CA of the London Borough of Camden Local Plan 2017.

- 4 Prior to commencement of development , full details in respect of the living roof in the area indicated on the approved roof plan shall be submitted to and approved by the local planning authority. The details shall include:

- i. a detailed scheme of maintenance
- ii. sections at a scale of 1:20 with manufacturers details demonstrating the construction and materials used
- iii. full details of planting species and density

The living roofs shall be fully provided in accordance with the approved details prior to first occupation and thereafter retained and maintained in accordance with the approved scheme.

Reason: In order to ensure the development undertakes reasonable measures to take account of biodiversity and the water environment in accordance with policies D1, D2 and A3 of the London Borough of Camden Local Plan 2017.

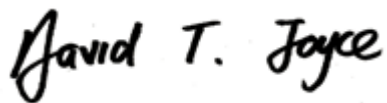
