Ensure a clearance of approximately 3.00m from surrounding structures. Clear street lamp by 1.50m. Raise crown by up to 2.00m. The tree can be clearly viewed from Perrins Walk.

Reason: General maintenance to help manage the tree at reasonable dimensions for its location, control encroachment & reduce potential hazards.
