T1London Plane x 1(Platanus x hispanica)Large mature previously pollarded plane tree in the rear garden. Suggested works: Re-pollard back to previous pruning points. (2-3 meters re-growth). Reduce height of ivy by 1-2 meters.
Rear garden
T2Sycamore x 1 (Acer pseudoplatanus) Large mature previously reduced Sycamore tree in the rear garden. Suggested works: Re-reduce all aspects of the crown back to previous pruning points. (2-3 meters re-growth) Reduce the height of the ivy to match the ivy on T1.
Rear garden
T3Horse Chestnut x 1 (Aesculus hippocastanum) Previously reduced Horse chestnut. Suggested works: re-reduce back to previous points of reduction. Retain a healthy amount of furnishing growth in order to facilitate a strong recovery.
Rear garden
T4Holly x 1(Ilex aquifolium) Suggested works: Reduce height to match the top of the shed.
Rear garden (right)
T5Purple leaf Plum x 2 (Prunus cerasifera 'Nigra') Unbalanced Purple leaf Plum in the rear garden. Suggested works: Reduce crown by 2 meters in order to alleviate some of the stress on the unbalanced crown.

T6Prunus spp x 1- Small dead prunus. Suggested works: fell and dig up stump.
