





Design

Context: The building is a family dwelling in an <u>Context</u>: The building is a family dwelling in an area where security issues and burglaries are common. The level of crime is one of the highest in London (please refer to the statistics shown on the following page). In order to improve security, the owners wish to install one discreet alarm bell box and four security CCTV cameras. Most of the buildings in the immediate neighbourhood have installed visible alarm bell boxes, most of them in more conspicuous positions than in our proposal. The samples shown on this page should give a good impression but are by no means exhaustive.

- 2 Provost Road is an early Victorian, Grade II listed, semi-detached house, built in 1844, and located at the south-eastern end of the Eton Conservation Area.
- It is a family dwelling and has received a number of alterations throughout its life. At the moment, it is being extended and altered, in line with granted planning and listed building approval 2017/4690/P and 2017/4702/L, variation of condition 3 of 2017/4690/P and 2017/4702/L granted, and 2018/2735/L, Approval of Details (Listed Building) Granted.



Context: The level of crime in this borough is one of the highest in London, with Provost Road being in an particularly exposed spot.

The Metropolitan Police constantly warn the residents of this neighbourhood about the high number of burglaries and thefts that are reported and advise on taking deterring measures, as e.g. clearly visible alram bell boxes and CCTV

The examples on the previous page show that the vast majority of residents have taken this advice on board and have implemented either one or both of these measures.

The graphs on this page show the crime statistics for the borough of Camden and for the immediate neighbourhood.



This shows that the crime rates for the last month alone have gone up by 3.25%.


2. Police Data for the Neighbourhood from January 2016 until present:

Since 2016, there have been seven burglaries on Provost Road, two on Eton Villas and five on Eton College Road.

In the case of Provost Road, this represents 35% of the houses in the street. Based on this figure, the chance of the client's property being burgled over the next five years is roughly 50%.






- <u>Proposal</u>: It is intended to position the alarm box above the rear kitchen door, which is in a more discreet position than in the majority of the neighbouring buildings. The 4 CCTV cameras are intended to be positioned in the front porch, behind the
- downstand (to be less visible from the street), in the side alley and at the rear elevation.
- <u>Amount:</u> The proposal will not increase the floorspace of the building.
- <u>Layout:</u> The intenal and external layout will not be affected by the proposal.
- Scale: The proposed works will not alter the size or shape of the building.
- Landscaping: No alteration to the landscaping is
- <u>Appearance:</u> The alarm bell box is to be white/grey with no logo. The cameras are to be white with black lenses.
- Use: No change of use is proposed.
- Access: The access to the site and building will not be altered in any way.
