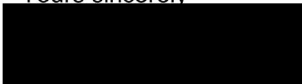

Thank you for your letter of 1 February 2019 regarding the above application for listed building consent. On the basis of the information available to date, we do not wish to offer any comments. 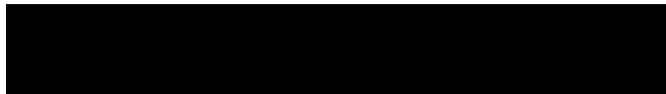
