Tree located in rear garden left hand boundary. A self down sycamore that has blown into the base of the boundary wall next door.

Sycamore, 10-12m in height, 50cm dch.

From the ground: tree lifting boundary wall that is listing into neighbours garden.

From the tree: on climbing the tree lots of movement from the stem. Slight lean towards children's play area. Unnatural movement was more obvious when moving around the tree.

Due to the position of the wall and garden layout it would be difficult to replant another tree in its place but happy to be advised.

The above is a summary of a detailed report carried out by a tree surgeon on my request having seen the leaning wall. Written report can be supplied upon request.
