(TPO REF. 13H-T71) FRONT GARDEN: 1 x Large Twin-Stem Lime (T1) - Remove all regrowth back to old pruning points to leave a bare framework as per previous practise. (TPO REF. C1040 2012) SIDE GARDEN: 1 x Large Chestnut (T2) - Remove all regrowth back to old pruning points to leave a bare framework as per previous practise. (TPO REF. 13H-G1) SIDE GARDEN: 4 x Large Lime (T3 -T6) - Remove all regrowth back to old pruning points to leave a bare framework as per previous practise.

The Council has considered your application dated 06 February 2019 and decided to grant consent subject to the following condition(s):
