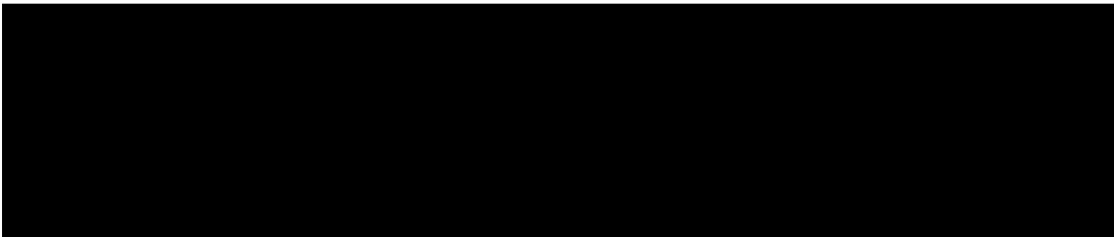

The Council have negotiated a revised scheme, please see the attached revised plans and they are also available to view online. Please let the Council know if these address your concerns and if you would like to remove your objection?

To summarise the following changes are proposed:

- Removal of replacement double glazing on the front elevation
- Removal of bin store, proposal will now just remove existing store and not replace it

Regarding the rear fenestration replacement with double glazing unfortunately there is a previous permission ref.2013/7553/P granting its replacement and this is a material planning consideration and the Council would have to support it in principle.
