Payment of £462.00 in respect of the application fee has been made via the planning portal.

The Site and Context

The site comprises Block A of the Postmark development site, which is currently undergoing redevelopment as permitted by planning permission 2013/3807/P. Block A forms part of Phase 1 of the wider redevelopment site and began construction in July 2018.

The scaffolding on the site is due to be erected in Spring this year and it is proposed that the scaffolding is wrapped in monarflex which will help with the containment of construction work as well as ensuring the site is of a tidy appearance.

The monarflex will be wrapped around the full extent of the scaffolding and therefore will follow the building form. At the highest point, the monarflex will be 65.800m AOD high.

This application proposes to have the 'Taylor Wimpey Central London' logo on the monarflex repeated across the monarflex as shown on included drawing pack and the example within the Proposed Monarflex Elevation, ref. 32875-05-1006 Rev P01.

Full details of the proposals are contained within the application forms and drawings submitted with this application. The monarflex is expected to be in place until July 2021 when the scaffolding is due to be removed.

The proposals are of a high-quality design and will improve the visual amenity of the area during construction works – the black (Pantone Black 7) and white colour scheme is clean and simple and will not detract from the amenity of the area. In addition, as the signage will not be illuminated the proposals will not give rise to any amenity or safety risks.
