Front Garden:

Robinia: Reduce crown by up to approximately 1.50m whilst preserving as much viable furnishing growth as is practicable to ensure crown continuity. Remove dead wood throughout. Remove low epicormic growth which overhangs No.98A. Remove epicormic stem growing over the pavement. Thin the density of the remaining low epicormic growth by 20% by means of removing the longest stems. Assess the structural integrity of the two main limbs described in the report and reduce or remove as required.

Reason: General maintenance.
