Tree type - Western red cedar (*Thuja plicata*) & Lime (*Tilia* Spp.)
Approx Height - 6-7m
Location - Rear garden, Right hand boundary
Service - Crown Reduction
Work required- Reduce height to approximately 1m below previous pruning points, to leave group standing at approximately 5m tall. Trim client's side back as hard as possible whilst retaining a green screen.
Reason - As part of continued maintenance, to manage size and allow more light to the client's and neighbour's gardens.

Tree number - G2
Tree type - 13x Lime (*Tilia* Spp.)
Approx Height - 8m
Location - Rear garden, Left hand boundary
Service - Re-pollard
Work required- Re-pollard trees back to previous points to leave standing approximately 6m tall. To include trimming down privet hedge close to house (see photo).
Reason - As part of continued maintenance

Tree number - G3
Tree type - Mixed shrubs
Approx Height - Up to 8m
Location - Right hand side of house and right hand boundary of front garden
Service - Hedge Trimming
Work required- Trim all growth overhanging from the neighbour's garden back to the boundary. Lightly trim client's spotted laurel. Reduce height of neighbour's elder and viburnum (front garden) by 1.5-2m (neighbour consent required).
Reason - As per client's wishes
