We inspected this tree with Mr Tusa and noted a large Ash tree in the rear garden. It was evident that this Ash is in decline and fruiting bodies were noted at 0.5m.

We suspect that the trunk is suffering with decay and possibly hollow.

REAR garden with side access via passage to Willow Road

T1 = Large ASH tree - Fell as close as possible to ground level.
