The trees in question, 3 No., are located at the junction of Gloucester Avenue, Regents Park Road and Oval Road, postcode NW1 7AT, OSGR: TQ28578369.

It appears that the site is within the boundary of the Primrose Hill Conservation Area, but please could you let me know whether these trees are also protected by TPO's.

Please could you advise on the requirement for TPO Consent and / or Conservation Area Consent.

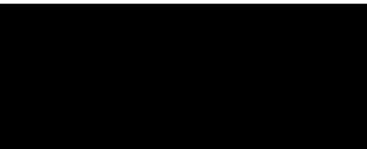
