Rear Garden:

T1: Eucalyptus: Located in No.5 The Grove. Reduce section of crown overhanging No.7 to previous most recent reduction points (approximately 25-30%), whilst preserving a suitable amount of furnishing growth to ensure crown continuity.

T2: Hawthorn: Located on right hand boundary of No.7. Reduce crown by approximately 20%. Thin crown density by 20%.

T3: Pittisporum: Reduce crown back to previous reduction points (approximately 20%). Reasons: General maintenance
