e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Sycamore T0704 (20M high, 1200mm dia.) - Thin crown throughout by up to 25%.

Reasons: Large tree with big canopy - reduction of sail area for co-dominant stems which are proposed for triple Cobra bracing as additional precautionary measure.

Common Lime T0705 (18 M high, 700mm dia.) - Major die-back at top of crown, declining. Reduce crown overall by up to 4 metres and back to live wood, re-shape and balance as required. Crown clean. Raise canopy to 4 metres above driveway.

Reason: Health and Safety for residents and surrounding area

Willow T1(12 M high, dual stem) - very poor condition with suspected Honey Fungus. Fell.

Reason: Potential dangerous tree - Health and Safety
