e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Common Lime T1 (16M high, 600mm dia.) - Leaning tree and twin co-dominant stems from 2 metres. Raise canopy al around up to 4 metres above boundary level beneath tree(sloping site). Reduce crown on leaning side of tree closest to the house by up to 3 metres and balance remainder as necessary. Reduce limb over studio by 1/3rd back to good growth point. Crown clean.

Common Lime T2 (16M high, 600mm dia.) Remove low branch facing house back to main stem. Face back low growth to hedge line.

Sycamore T3 (10M high, 500mm dia.) - Raise canopy all around to 2 metres above top of Laurel boundary hedge. Crown clean.

Holly x 2 T4 (7 M high, 2 x 175mm dia.) - Reduce down to 4 metres high and face in on garden side to create screen.
