We have had 4 arson attacks recently in our private road, mainly setting fire to recycling bins. Last night a skip was set on fire and required the fire brigade. The bins in the bus area of South End Green were also set ablaze last night. The proximity of the bins and skip to the properties and/or vehicles is normally less than 1 metre. This is clearly becoming a serious matter and in my opinion is only a matter of time before one of the properties is set on fire. The attacks have been taking place around 4am when everyone is asleep in the properties.
