Rear Garden:

T1: Sorbus: Approximately 10.00m. Fell to as near to ground level as is practicable. Grind stump to approximately 300mm below current ground level. This tree is to be replaced by 2 x Pear trees. Reason: This tree is twin stemmed. The larger stem of the two is completely dead and the second minor one is also dying back.

T2: Holly: Approximately 9.00m. Reduce lateral and sub lateral growth by approximately 20-25% to form a more compact & balanced crown line.

T3 & T4: 2 x Pines: Approximately 8.00m. Remove dead wood throughout.

Reason: General maintenance unless otherwise specified.
