The Council has considered your application dated 27 February 2019 and decided to grant consent subject to the following condition(s):

## Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, which ever is the sooner.
  - Reason: To allow the Local planning authority to monitor the completion and standards of the work.
- All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the



tree(s).

Prior to the end of the next available planting season following the completion of works, 1 no. Prunus "Amanogawa" (upright cherry), 12-14cm in girth shall be planted in the front garden of the property no less than 500mm away from any structure unless otherwise agreed with the council in writing. The trees shall be planted and maintained in line with BS8545:2014.

Reason: To ensure that the replanting achieves a high quality of landscaping which contributes to the visual amenity and character of the area.

## Informative(s):

Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
