Proposal:

FRONT GARDEN: 1 x Sycamore (T1) - Reduce crown by 35%, 4 - 5m of height and width.

1 x Sycamore (T2) - Reduce crown by 30%, 2.5 - 3m of eight and width.

1 x Silver Birch (T3) - Reduce crown by 30%, 2 - 3m of height and width.

REAR GARDEN: 1 x Lime (T4) - Thin out crown by 20% to 25% and lift canopy to 6m.

The Council has considered your application dated 21 March 2019 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- This decision is valid for 2 years from the date of this decision or until the work is completed, which ever is the sooner.
 - Reason: To allow the Local planning authority to monitor the completion and standards of the work.

Reason: To ensure the preservation of the amenity value and health of the tree(s).
