It is important in the health and safety of both SafeStore and residents Mayford that permission is granted due to the long ongoing issues of drug dealing, drug taking, related crime and thefts to feed addictions; and anti-social behavior that have made the estate rather dangerous for us all, particularly for our children, elderly and vulnerable residents. Drug dealers/takers/abusers, rough sleepers and criminals etc use the currently open area outside SafeStore to ply their activities and discarding dangerous used drug paraphernalia and needles placing the health and safety of our children and residents at risk. Other criminal activities include the frequent illegal parking of large luxury type cars in this area, probably for drug dealing purposes, playing loud music, shouting and disturbing residents. Fires are often lit in the open area and neighboring undercroft next to gas pipes serving the estate and SafeStore; that could cause a Corydon type fire and the negative press this will bring, or a gas related explosion, leading to possible partial building collapse, deaths and related legalities. 				To this end, the application exaggerates it's justification slightly, as the photos mentioned are very roughly in the vicinity of the store, up to about a minute's walk away, but a few would be unreachable to a safestore customer, however, I do appreciate that Safestore acknowledges the general sense of safety for residents as well as their own staff and customers.
				In summary - this planning application doesn't quite go far enough, as there's still a risk of gas explosion (Safestore Application Overview appx B, fig.9), which isn't being protected according to this submission (see squiggly lines to the right of the building containing numbers 159-163 and 180-184 on document 4458.10E PROP SITE PLAN 1of2), so it would be proper to extend the fence slightly to these recesses too , where possible.
