I am writing to object to the microclimate mitigation measures proposed by Essential Living in their response to condition 15 of Planning permission 2014/1617/P dated 18/02/2016.

Essential Living's proposed plans to mitigate the extreme wind factor that will inevitably result from their 24 storey towers and be much worse than the existing wind tunnel – are, frankly, ludicrous. It is nothing short of preposterous to propose that potted plants and shrubbery can counter the increased wind factor that will adversely affect the public using the existing market and Hampstead Theatre space and the public Open Green Space. And in regard to fire safety and emergency access, the proposal to install heavy granite planters in the narrow space between the proposed new build and the Hampstead Theatre

would make emergency access to the Towers, Green Space, Farmer's Market, Swiss Cottage tube entrance and Hampstead Theatre very difficult if not almost impossible. As with so many aspects of this 100 Avenue Road application, it beggars belief that Camden just keeps on approving and approving.

Perhaps in this instance Camden will listen to reason and not the sound of £££'s clinking into their coffers.

I ask that this application be refused.
