e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Garden:

T1: Willow: Approximately 6.00m. Located very close to the boundary wall. Some cracking was noted which can be attributed to the tree. Fell to ground level and treat with systemic herbicide.

T2: Elder: Approximately 6.00m. Fell to ground level and treat with systemic herbicide and replant a more suitable specimen.

T3: Bay: Approximately 8.00m. Reduce crown height by 30-40%. Reduce lateral and sub lateral branches by 20-25% to balance and shape. Raise crown by 0.50m. Remove climbing plant from crown.

T4: Dead Gleditsia: Remove.
