TG2 Mixed species group of False Acacia, Hawthorn, Ash, Privet and Elder of MWA Arboricultural Report

Works: Remove (fell) False Acacia and Ash elements to ground level and treat stumps to inhibit regrowth. Do not allow remainder of group to exceed current dimensions.

TG3 Mixed species group of Ash and Cypress

Works: Remove (fell) Ash to near ground level and treat stumps to inhibit regrowth. Do not allow Cypress to exceed current dimensions by way of regular [annual] trimming.

Reason: Clay shrinkage subsidence damage
