The youth centre is part of the Dome site which has permanent planning permission therefore the impact on the regeneration plan is none. Issuing a shorter planning permission will only mean more money from youth activities will be taken to pay Camden's fees or risk the closer of youth service. QCCA paid over £20k fees in 2014 to secure the planning permission, upto £18k was requested on this round, it can't afford to pay Camden the same fees for the the third time.
