Tidy up limb and selectively reshape remainder by 0.5-1m to form a neater specimen. Remove major deadwood.

T5 = Large CATALPA - Remove lowest limb. Remove deadwood and stubs.

T7 = Large TULIP tree - Remove major deadwood only.

GRP1 & GRP2 = Large Mixed VEGETATION – Face back to the boundary line.
