FRONT garden T1 = Large LIQUID AMBER -Crown reduce height and lateral branches by 0.5m and selectively reshape. REAR garden with side access T2, T4, T6 = $3 \times \text{Medium LAUREL trees} -$ Crown reduce height and lateral branches by 0.5 - 1m + reshape. T3 = Medium PRUNUS -Tidy up limb and selectively reshape remainder by 0.5-1m to form a neater specimen. Remove major deadwood. T5 = Large CATALPA - Remove lowest limb. Remove deadwood and stubs. T7 = Large TULIP tree - Remove major deadwood only. GRP1 & GRP2 = Large Mixed VEGETATION - Face back to the boundary line.
