The first-floor balcony was approved as part of the original treehouse application (application reference 2009/2777P), approved on 31st March 2010 and is clearly shown on the approved plans (see drawing numbers 508/100/18A Section A-A, 508/100/17A East Elevation and 508/100/16A South Elevation). It is noted that a number of minor amendments were submitted to the Council by way of a Certificate of Lawfulness for the Existing Development in December 2017 (application reference 2017/6888), these did not relate to the design, location or appearance of the first-floor balcony approved under reference 2009/2777P.

Camden Council have accepted by way of the above-mentioned applications that the design, location and appearance of the first-floor balcony has been established.

This application is simply to regularise the like for like replacement of the balcony which is no longer safe to use.
