 - Thin crown to remove approximately 10% of live branches to reduce branch density. Most thinning cuts will be between 1 and 2 centimetres in diameter.
 - Reduce crown height and spread by approximately 2-3 metres to enhance natural form.
- Prune T2 Cherry located at the front of house according to the following specifications:
- Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.
 - Reduce crown height and spread by approximately 1-2 metres to enhance natural form
