ENFORCEMENT NOTICE

ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THE NOTICE RELATES**

Land at: : Basement and Ground Floors, 46 Birchington Road, London, NW6 4LJ as shown outlined in black on the attached plan ("the Property").

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without planning permission: Unauthorised installation of timber decking and associated timber enclosure to front forecourt area.

4. **REASONS FOR ISSUING THIS NOTICE:**

- a) The unauthorised development has occurred within the last 4 years.
- b) The timber decked area and associated enclosure due to its size, design and location is considered to be an incongruous addition, which has a detrimental impact on the character and appearance of the host building, existing streetscene, and the surrounding area contrary to policy D1 of the London Borough of Camden's Local Plan 2017.

- c) The terrace area by reason of its proximity to the windows of the residential dwellings located on the upper floors and hours of use, is likely to result in noise nuisance at unsociable hours to the detriment of the amenity of neighbouring occupiers and is thereby contrary to policy A1 of the London Borough of Camden's Local Plan 2017.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of **ONE (1) month** of the Notice taking effect:

1. To totally remove the timber decking and associated enclosure located on the front forecourt area, and make the development comply with the planning permission granted on 12/02/2014 (ref: 2014/5696/P); and
2. Make good any damage as a result of the above works

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **4 JULY 2019** unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

YOUR RIGHT OF APPEAL

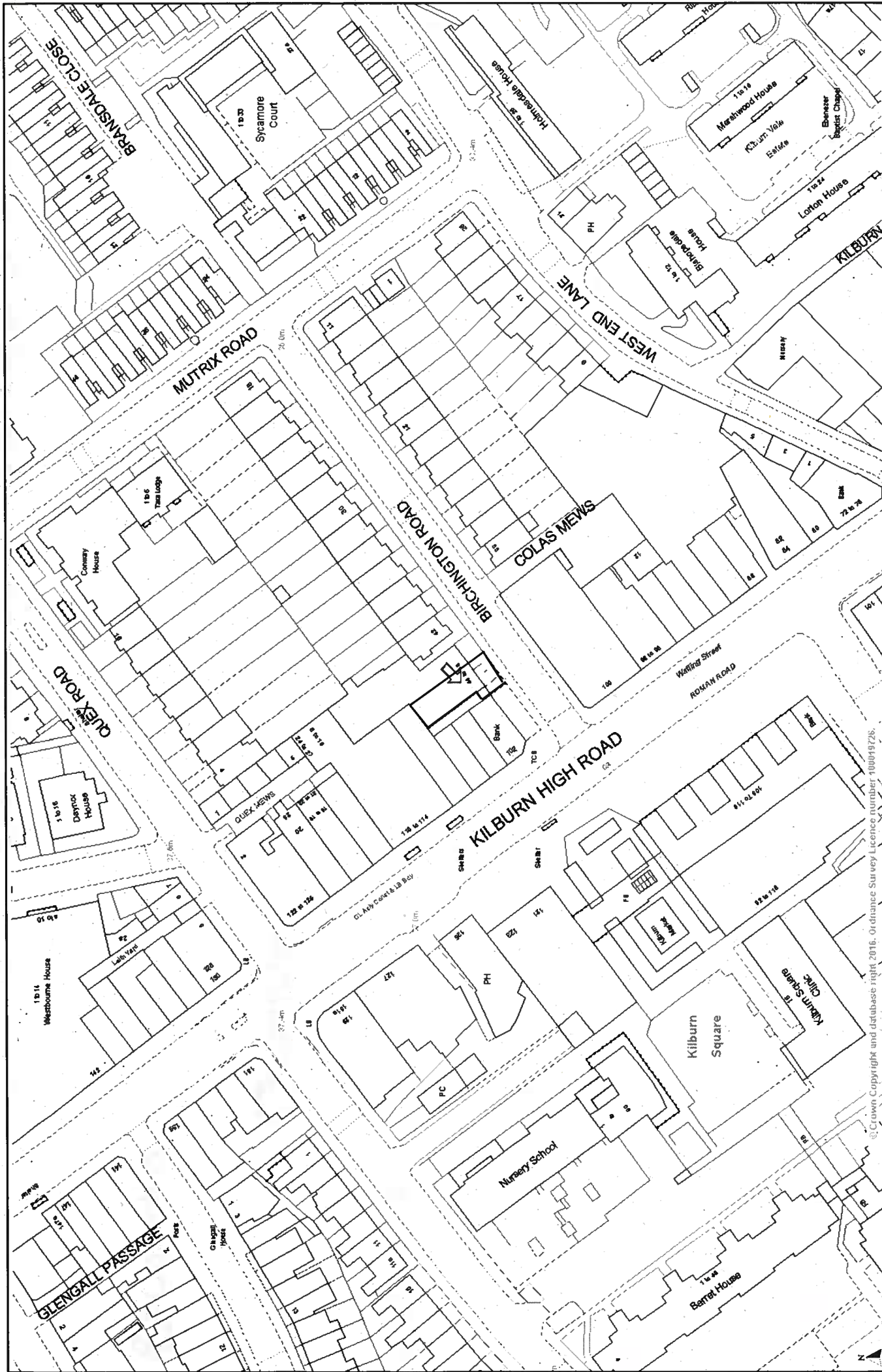
