e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Garden:

T1: Laurel: located on the right hand boundary. Reduce crown by approximately 30%.

T2: Oak: Located on the left hand boundary. Remove dead wood throughout crown. Reduce crown by approximately 20%. Thin crown density by 20%.

T3: Lime: Growing within the curtilage of No.70 but very close to the boundary so has near equal affect on both properties. Thin crown density throughout by approximately 20-25%. Remove dead wood. Judiciously reduce lateral branches by up to 20% as required to control encroachment.

G1: Group of self sown Sycamore & Ash: Overhanging from naturalised land behind the rear boundary. Reduce overhang by 1.50-2.50m, back to as near to the boundary as is practicable from ground level with extended pole pruners.

Reasons: General maintenance and to improve light levels.
