The 10 external advertisements (which have already been installed and used for advertising billboards for several months) have visually harmed the appearance of the Stables market's external wall (and surrounding area), and have also invited graffiti and vandalism which has not previously been present on this wall.

I do not believe that the use of these boards for advertisement is respectful/considerate of the special architectural and historic interest of the walls. I would invite the applicant/council to consider returning these boards to their original intended purpose (which was for the installation of artwork) or remove them entirely.
