Full Planning Permission Granted

Address: Regent's Park Outer Circle London NW1 4NR

Proposal: Temporary erection of Frieze Sculpture Park sited in the English Gardens from July 2019 to October 2019.

Drawing Nos: Site location plan received 20/12/2018, Frieze sculpture work placement map received 20/12/2018, arboricultural report dated May 2019 ref. 19-812-Report-C and tree protection plan ref. 19-812-TPP-C by Canopy Consultants.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted shall be carried out in accordance with the following approved plans: Site location plan received 20/12/2018, Frieze sculpture work placement map received 20/12/2018, arboricultural report dated May 2019 ref. 19-812-Report-C and tree protection plan ref. 19-812-TPP-C by Canopy Consultants.

Reason: For the avoidance of doubt and in the interest of proper planning.

2 The structures hereby permitted are for a temporary period only and shall be removed on or before 14 October 2019.

Reason: The type of structures are not such as the Council is prepared to approve, other than for a limited period, in view of their appearance. The permanent retention of the structures would be contrary to the requirements of Policies D1 and D2 of the Camden Local Plan.

3 Details of the existing gardens and park where the temporary structures will be displayed must be recorded prior to the erection of the structure. Once the structures have been dismantled, the park and gardens shall be returned to their original condition.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of Policies D1 and D2 of the Camden Local Plan.

Prior to the commencement of works on site, tree protection measures shall be installed and working practices adopted in accordance with the arboricultural report dated May 2019 ref. 19-812-Report-C and tree protection plan ref. 19-812-TPP-C by Canopy Consultants. All trees on the site, or parts of trees growing from adjoining sites, unless shown on the permitted drawings as being removed, shall be retained and protected from damage in accordance with BS5837:2012 and with the approved protection details. The works shall be undertaken under the supervision of the project arboriculturalist.

Reason: To ensure that the development will not have an adverse effect on existing trees and in order to maintain the character and amenity of the area in accordance with the requirements of policies A2 and A3 of the Camden Local Plan.

Informative(s):

1 Reasons for granting permission.

There would be approximately 19 temporary exhibits of different sizes for the Frieze Sculpture Park. The sculptures are considered acceptable as small scale artistic structures for a temporary basis only and would not harm the character and appearance of the open space and Conservation Area, provided that they are not retained permanently. The exhibits will be placed securely on grass away from the flow of public movement and will be managed throughout the duration of the display. In order to preserve the appearance of the open space and Conservation Area, a condition is attached to ensure that the grass is made good following any damage as a result of the exhibition.

Due to the requirement to dig shallow foundations for the sculptures, and their locations close to existing trees, details of tree protection measures have been submitted which the Council's Trees & Landscaping Officer has reviewed and confirmed is sufficient to demonstrate that the trees to be retained will be adequately protected in line with BS5837:2012.

Due to the location and temporary nature of the sculptures, they are not considered to cause harm to neighbouring amenity in terms of loss of daylight, outlook or privacy.

No objections have been received prior to the determination of this application. The planning history of the site has been taken into account when coming to this decision.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Conservation Area, under s.72 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposed development is in general accordance with policies A1, A2, A3, D1, and D2 of the Camden Local Plan. The proposed development also accords with The London Plan 2016, and the National Planning Policy Framework 2019.

- 2 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. - 3 This approval does not authorise the use of the public highway. No 020 7974 4444). Licences and authorisations need to be sought in advance of proposed works. Where development is subject to a Construction Management Plan (through a requirement in a S106 agreement), no licence or authorisation will be granted until the Construction Management Plan is approved by the Council.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2019.
