Re: Application for Listed Building Consent for the installation of internal secondary glazing at 35A Mornington Terrace, London, NW1 7RS

Costain Skanska Joint Venture (CSJV) is submitting listed building consent applications on behalf of High Speed Two (HS2) Ltd for works to properties eligible for the HS2 construction noise insulation scheme that are listed buildings. The noise insulation works proposed within this application comprises internal secondary glazing for identified windows on eligible facades with supplementary acoustic ventilation.

This application relates to 35A Mornington Terrace, a Grade II listed building on the eastern side of Mornington Terrace, which is also within Camden Town Conservation Area.

This application includes a 'Slimline' solution. The resident/ property owner has been made aware of the reduced gap between the existing and secondary glazing and the reduction this may have on the noise attenuating performance of the secondary glazing. See submitted Heritage Statement for further details.

If HS2's offer of mechanical ventilation is accepted by the resident/ property owner, this shall be the subject of a subsequent application.
